SOUTHERN CALIFORNIA EDISON COMPANY'S NOTICE OF APPLICATION FILING REQUESTING TO INCREASE RATES FOR GREEN ENERGY PROGRAMS

A.18-09-015

Summary

On September 26, 2018, Southern California Edison Company (SCE) filed Application (A.) 18-09-015 with the California Public Utilities Commission (CPUC) requesting approval to increase rates for its Green Energy Programs (Green Energy Programs). SCE is requesting to increase rates by up to \$5.875 million to recover costs associated with the Green Energy Programs, beginning in 2020. SCE also is seeking authority to offer a discount on the cost of participating in an eligible Green Energy Program for qualifying participants. This discount is estimated to cost \$7.329 million through 2030. If approved, the Green Energy Programs will offer a variety of options for customers to purchase renewable energy resources to meet their electricity needs. SCE designed the Green Energy Programs to give customers clean energy options, support California's clean energy and greenhouse gas (GHG) emission reduction goals, and provide customers with affordable access.

Rate Impact of SCE's Application

If the CPUC approves SCE's application as proposed, an average non-CARE residential customer using 550 kWh per month could see a monthly bill increase of 0.02%, from a current monthly bill of \$111.32 to \$111.34. The following table compares SCE's current bundled average generation rates, by customer group, to proposed bundled average generation rates in 2019 if SCE's application is approved by the CPUC:

CPUC Process

The application will be assigned to one or more Administrative Law Judges (Judges) who will determine how to receive evidence and other related documents necessary for the CPUC to establish a record upon which to base its decision. Evidentiary Hearings (EHs) may be held where parties of record will present their testimony and may be subject to cross-examination by other parties. These EHs are open to the public, but only those who are parties of record can participate.

After considering all proposals and evidence presented during the formal hearing process Judges will issue a proposed decision which may adopt SCE's application as proposed, modify it, or deny it. Any CPUC Commissioner may sponsor an alternate decision. The proposed decision, and any alternate decisions, will be discussed and voted upon at a scheduled CPUC Voting Meeting.

The Public Advocates Office (Cal PA, formerly Office of Ratepayer Advocates (ORA)) may review this application on behalf of SCE's customers. Cal PA is the independent consumer advocate within the CPUC with a legislative mandate to represent investor-owned utility residential and small commercial customers to obtain the lowest possible rate for service consistent with reliable and safe service levels. Cal PA has a multi-disciplinary staff with expertise in economics, finance, accounting, and engineering.
